Shelter-in-place/lock-down procedures

If we need to stay in the building due to an emergency, the following procedures will be followed:

LOCATION 1 (IN-BUILDING) Closest lockable space to classroom	LOCATION 2 (IN-BUILDING) 2nd closets lockable space to classroom
DESCRIBE PROCEDURES FOR SHELTER-IN-PLACE/LOCK-DOWN (WHO, WHAT, WHERE, WHEN): Ladybug Child Care Center occasionally finds it advisable to enforce a lock down to provide additional security to the staff and children. Administrators, Department Managers, and Teachers (most senior person on site makes this decision) may enforce a lock down if needed. The children are kept quiet, calm, and away from the windows until the threat is gone. Green and red signs (found in black binders and on the backs of doors in secured areas) are used to communicate locations and conditions to emergency personnel. Green signals "all clear" while red means "need help". Place appropriate signs in windows and/or beneath doors. Threat from outside the building: The blinds are closed, the doors are locked, and everyone is secured inside the building. CALL 911. No one leaves/ enters the building except as determined by a manager or administrator. Threat from inside the building: Immediately move all children and staff to securable areas. Depending upon the facility, these will include offices, mechanical rooms, locked closets and storage rooms, and staff bathrooms. Be sure to remove the key from door frames upon entering. CALL 911. Do not open the door for anyone but a police officer.

Evacuation and relocation procedures

If we need to evacuate our site and relocated to another site, the following procedures will be followed:

DESCRIBE EVACUATION ROUTES AND EXITS. SHOW HOW YOU AND THE CHILDREN WILL LEAVE FROM ANY ROOM IN THE BUILDING:

Emergency evacuation routs are posted in each classroom.

For evacuation, staff lead children out the nearest safe exit. Once outside of the building, everyone proceeds directly to the designated meeting place. Teachers take attendance to ensure that everyone has been evacuated. Infants are evacuated by placing them in the designated evacuation cribs. There are wagons to aid in the evacuation of young toddlers.

Employees should bring their purses and cell phones in an evacuation. If the Center has a bus, bring the keys.

The Center bus and staff cars can be used to help transport young children as needed.

Parent/guardian and child reunification procedures

If we need to evacuate, shelter-in-place, or when parents/guardians are unable to get to children, the following procedures will be followed to reunite children with parents/guardians or designated contacts as soon as it is safe:

PARENTS/GUARDIANS WILL BE NOTIFIED WHEN: The situation is under control and it is safe to do so.
DESCRIBE HOW YOU WILL KEEP PARENT/GUARDIAN INFORMATION UP TO DATE. HOW WILL YOU ACCESS THIS INFORMATION IN AN EMERGENCY? Parent information is kept up to date in the black binders and in tadpoles.
DESCRIBE HOW CHILDREN WILL ONLY BE RELEASED TO PARENTS/GUARDIANS OR OTHER INDIVIDUALS LISTED ON THE CHILD'S FORM (WITH PROPER IDENTIFICATION). INCLUDE ANY RELEVANT DETAILS ABOUT RELEASE OR REUNIFICATION: Children will be released to individuals authorized by parent upon showing proper identification.

Continuing operations procedures

In the period during and after a crisis, the following procedures will be followed regarding continuing operations:

Fire	<p>When the fire alarm sounds, before opening a door, feel for heat on the surface. If it is hot, take another exit. Immediately get yourself and the children outside. Gather everyone in a designated spot and take attendance. CALL 911. If there is time take your black binder, I Pad, cell phones, purses, and bus keys. Do Not go back in the center until responders say it is safe to do so.</p> <p>If you are trapped inside, try to get everyone to a safe place inside the center. Take attendance to account for everyone. Seal doors between you and the fire. Place wet blankets or towels at the bottom of doors to slow/stop smoke from coming into the room. Try to keep children and yourself calm. Contact the fire department however you can.</p>

Gas/Chemical Leaks	
Hazardous Materials	Call 911 as soon as possible if you see a hazardous materials accident, spill or leak. Turn on the radio or computer and listen for instructions from emergency responders. Follow their advice immediately.
High or Low Temperatures	Overheating in hot weather, frostbit and hypothermia in cold weather poses a risk to children. Children are to be kept inside when heat index is 95 or higher and windshield is 0 or below.
Infectious Diseases	Use infectious disease book to determine contagious illness, incubation periods, treatment, and exclusion recommendations.
Nuclear Power Plant There are two nuclear power plants in MN (in Welch and Monticello). Depending on location you may/may not have "potential risk of harm".	N/A
Severe Winter Weather	Except in the most extreme circumstances, the Center is open. In bad weather, parents are encouraged to call the Center before leaving home to ensure that an employee has arrived at the Center. If Administration makes the decision to close, parents are notified via tadpoles with the change in hours. In extreme weather circumstances, employees and children may be kept overnight or

Thunderstorm	The Center is alerted to thunderstorm warnings via the city's civil defenses siren system, media broadcasts, and other alert systems. Child emergency contact information

Keep the following information with your emergency kit(s) in case of an emergency:

Child specific information:

- Child's name
- Child's address
- Child's date of birth
- Special instructions for children with disabilities or chronic medical conditions (if applicable)

Parent/guardian information:

- Name(s) & relationship to child
- Preferred contact information (i.e. phone number or email address)
- Alternate emergency contacts
- Individuals authorized for pick-up

For licensed family child care providers, this information is on the first page of each child's Admissions and Arrangements form. Keep a copy of the first page of each child's Admissions and Arrangements form with your emergency kit(s) so that the information can be easily accessed in an emergency.

Please note: Do not post any child-specific information with your emergency plan or share it with other parents.
